



Voluntary Contributions Policy

This policy applies to 2024 enrolments and should be read alongside the Free Kindergarten Fees Policy.

1. Why Voluntary Contributions are vital to the viability of Ripponlea Kindergarten

The Department of Education (DE) provides per capita and Free Kindergarten funding as a contribution toward the costs of providing Three-Year-Old and Four-Year-Old Kindergarten programs. **Services meet the balance of costs through voluntary contributions and fundraising activities.**

Ripponlea Kindergarten has opted into the Free Kindergarten initiative, so while mandatory fees cannot be levied, the Kindergarten is requesting a voluntary contribution be made that covers the difference between the amount the state government pays under the Free Kindergarten initiative and the fee that would have applied in the absence of Free Kindergarten.

How voluntary contributions are computed

A condition of Ripponlea Kindergarten opting into the Free Kindergarten initiative is that mandatory fees cannot be charged to parents, other than in certain circumstances described in this document such as the holding fee and late collection fee. However, a **voluntary contribution can be requested, being the difference between the Free Kindergarten funding and the fee that would have applied in the absence of Free Kindergarten.**

Voluntary Contributions are used to pay for fixed costs such as wages, rent, maintenance and educational resources used for the children's program.

As part of the budget development process, the Committee of Management sets budgets each year for the programs of the service, considering:

- the financial viability of the service
- the level of government funding provided for the program
- the availability of other income sources, such as grants
- the capacity of parents/guardians to contribute
- reasonable expenditure in meeting agreed program quality and standards

2. Other charges

Holding fee: The holding fee secures your child's place at Ripponlea Kindergarten and is payable on acceptance of enrolment. When enrolment is accepted, a \$250 holding fee is levied. The holding fee is calculated pro rata for mid-year enrolments: Term 1 - \$250.00, Term 2 - \$225.00, Term 3 - \$150, Term 4 - \$75.00. Once the child commences at the kindergarten, the holding fee will be refunded unless the parents/guardians agree to allocate

the holding fee towards voluntary contributions. This fee is **not refundable** where the child's enrolment is withdrawn and the child does not commence at the kindergarten.

Late collection fee: The Committee of Management reserves the right to implement a late collection fee when parents/guardians are **frequently late** in collecting a child from the service. This fee is based on \$10 for every 10 minutes, or part thereof, from the end of the session. This is monitored and invoiced by a late book near the sign in sheet. The teachers also have commitments to attend outside of the Kindergarten hours and are not paid for an extended period after the session ends.

Excursion/service event charge: At times throughout the year an additional excursion(s) or event(s) may be arranged where it is considered relevant to the service's program and the children's interests. At this time any additional costs to families are taken into consideration before a decision is made (*refer to Excursions and Service Events Policy*).

3. Payment of voluntary contributions

A Voluntary Contribution request/invoice will be sent each term, being **\$250 per Term for 4 year old groups and \$125 per Term for 3 year old groups**. Where a Holding Fee has been paid to secure a child's place, as part of enrolment, parents/guardians can choose to allocate the holding fee towards voluntary contributions. For example, the \$250 holding fee can be allocated towards the \$250 Term 1 voluntary contribution for 4 year old groups, or the \$125 Term 1 and Term 2 voluntary contributions for 3 year old groups. Once the holding fee has been fully allocated, parents/guardians can choose to make additional payments for the voluntary contributions.

If you do not wish to pay the voluntary contribution, please respond to our bookkeeper who issues the invoice, notifying them that you would prefer not to pay, and the invoice will be removed from your account.

4. Children turning 3 and other children starting during the year of enrolment

Children can only commence the Kindergarten program once they have turned 3 and they must have had their third birthday by 30 April during the year of enrolment. A Voluntary contribution request will be computed pro-rata from a child's commencement date at the Kindergarten service.

5. Enrolment Agreement Form

All families must complete and submit the online Enrolment Form agreeing to the conditions as stipulated in this Voluntary Contribution Policy before the child commences at the Kindergarten.

6. Voluntary Contribution schedule
